I would like to share some of my thoughts with those persons who do have choices and yet who resist trying new technologies.



# IFHOH President's Message

The IFHOH Biennial General Meeting and Conference is just days away, from April 5-7, 2014 in Jerusalem, Israel and excitement is increasing as April approaches. I look forward to meeting members and friends at the series of events and obtaining your ideas and thoughts about the work of our organization. In this issue you will find the Biennial report of IFHOH which will presented at the BGM. We have also developed an action plan that outlines our priorities for the coming two years and invite further comment on the plans.

Priorities are centered around continuing our work to promote the Convention on the Rights of Persons with Disabilities (CRPD) for our community and on taking a leadership role within the International Disability Alliance (IDA). We also look forward to delivering CRPD training workshops and are applying to granting agencies to help fund this important work. A document has been produced as a Toolkit on the UN CRPD to be discussed at the BGM. It is on our website.

We have also developed an Education Policy paper which will be discussed at the BGM. If adopted, the paper will add to our existing body of work that includes a paper on Cochlear Implants and Accessibility.

In our action plan for 2014-2016 we commit to developing a policy paper on hearing aids. At the same time we will continue to promote existing papers and we will revise our Accessibility paper to ensure that it is current and as applicable today as when adopted four years ago.

We also look forward to discussing and determining with you a mutual date for a global Hard of Hearing Awareness Day for UN Adoption, an endeavor that requires a lot of groundwork to make it happen from talking with others who pursued a day for their cause.

We are also looking forward to developing a speech-to-text (also known as captioning) project given the importance of this form of access to our members. An initial start will be to identify the current situation in different countries.

I was pleased that quality speech-to-text was provided at a meeting of African leaders in the disability movement along with leaders of international organizations for different disabilities, organized by the International Disability Alliance (IDA).

It was a significant conference and I was particularly pleased to

- Continue a leadership role in the International Disability Alliance.
- Liaise with EOSOC, UNESCO, the World Health Organization and the World Bank

- Develop a Speech-to-text or captioning project with the World Federation of the Deaf
- Liaise with the Asia Pacific Federation of the Hard of Hearing and Deafened (APFHD) including participation in their May 2014 Forum.

#### **Governance and Capacity-Building of IFHOH**

- Explore the feasibility of a hard of hearing outreach project in the Middle East.
- Liaise with HLAA, the host for the 2016 BGM and Congress.

- Expand IFHOH's network to other parts of the world.

# IFHOH Biennial Report 2012 - 2014

The Board of the International Federation of Hard of Hearing People is pleased to provide this biennial summary of its status and activities during the period of 2012 to 2014. This report is prepared for the Biennial Meeting of IFHOH being held April 7, 2014 in Jerusalem, Israel.

The report is divided into sections discussing: Governance, CRPD-related Activities, Hearing Issues, and Other Presentations and Activities.

#### **GOVERNANCE**

Officers elected at IFHOH's 2012 Biennial Meeting on June 25<sup>th</sup>, 2012 in Bergen, Norway were:

- Ruth Warick, Canada, President
- Avi Blau, Israel, Vice-President
- Hang Duong Phuong, Vietnam, General Secretary
- Niklas Wenman, Finland, Treasurer
- Ulf Olsson, Sweden, Member at Large (on leave from September of 2013)

Marcel Bobeldijk, Netherlands, President of the European Federation of Hard of Hearing People, was confirmed as a member of the board as a regional representative.

During 2012-2014, the IFHOH board held three face-to-face meetings as follows:

October, 2012 Stockholm, Sweden
 March, 2013 Helsinki, Finland
 October, 2013 Eastbourne, England

At the October 2012 meeting the board arranged for CART to be provided by remote means for the first time. The board also began holding monthly Skype meetings as of December 2013, with meetings held: December 20, 2013; January 25, 2014; and February 7, 2014.

An Action Plan in four key areas guided the board as well as the motions adopted by members at the BGM. The four key areas of the Action Plan were hearing issues, information and communication, cooperation with and participation with other organizations, and internal IFHOH matters.

Lilian Lindqvist served as corresponding secretary through a contract with the Swedish Association for Hard of Hearing People (HRF), as a shared arrangement with EFHOH, until the end of 2012. The arrangement was ended at the request of HRF due to their own requirements. Therefore, the responsibility for maintaining the membership list of IFHOH was transferred to the General Secretary.

IFHOH and EFHOH jointly implemented a Gold Sponsor fundraising program in 2013 and Bernafon became the first Gold Sponsor under the program. The number of sponsors is expected to increase in 2014. Our sponsoring members are:

#### Membership:

As of the end of 2013, IFHOH had 40 General members, 7 Associate members, 2 individual members, 1 Gold Sponsor, and 6 other sponsoring members. We are represented in 36 countries. Previously we were represented in 29 countries.

In 2012-2014 the Board approved as new general members the following:

Emmanuel Sackey of Ghana and Ubenyl Johnson of Nigeria were welcomed as individual members.

Within Europe, two new general members welcomed to IFHOH were:

- Hungarian Hard of Hearing Association, Hungary

#### Marcia Dugan Fund:

A Call for Applications was issued in 2013 for sponsoring one participant to attend the 2014 BGM in Israel. The Fund was established in honour of the late Marcia Dugan, a former president of IFHOH.

#### Communications:

In October 2012 IFHOH launched its own Facebook page thanks to the expertise of IFHOH Vice-President Avi Blau. The address is <a href="https://www.facebook.com/groups/IFHOH/">https://www.facebook.com/groups/IFHOH/</a>.

Carole Willans of Canada continued as Editor of the *IFHOH Journal* posted online on the IFHOH website. Seven issues were posted.

Additional translations to the IFHOH brochure were made into Vietnamese. Previously, the brochure was available in Arabic, Dutch, English, French, German, Spanish and Swedish on the IFHOH website.

Pertti Köyste continued to serve as webmaster for the IFHOH. An on-line survey about the webcasts of the Convention on the Rights of Persons with Disabilities Committee's 10th session and the High Level Meeting on Disability and Development (HLM DD) provided by the UNOG (Geneva) and the UN DESA (New York). The results of the survey were reported to UN DESA and emphasized the issue of more promotion of on-line captioning of UN events.

#### CONVENTION ON THE RIGHTS OF PERSONS WITH DISABILITIES

Action was taken on a motion concerning the Convention on the Rights of Persons with Disabilities passed at the IFHOH 2012 biennial general meeting in Bergen, Norway. We wrote to Ron McCallum, Chair and Committee Members of the UN Committee on the Rights of Persons with Disabilities on the Convention on the

#### Rights of Persons with Disabilities to urge:

- That the Committee to include the hard of hearing perspective in their monitoring and reporting.
- Those national mechanisms monitoring the UN Convention on the Rights of Persons with Disabilities include the hard of hearing perspective in their monitoring and reporting.
- That governments use the CRPD as the point of departure in their disability policies and work actively for the ratification and implementation of the CRPD.

The board created the position of a Human Rights Officer. As a result of a recruitment process in April 2013, Louise Carroll of New Zealand was hired for the position. Through the International Disability Alliance, of which IFHOH is a member, she was sponsored to attend a week-long training event in Geneva in April, 2013. The training programme also included meetings with senior officials from the International Labour Organization (ILO), Office of the High Commissioner for Human Rights (OHCHR), the United Nations Children's Fund (UNICEF) and the World Health Organization (WHO).

The HR Officer's main task for 2013 was to develop a toolkit on the Convention on the Rights of Persons with Disabilities. *IFHOH's United Nations Convention on the Rights of People with Disabilities Implementation Toolkit* is a resource about the CRPD with particular focus on its application to the issues of concern to the hard of hearing community. It is posted on the IFHOH website in a section entitled human rights.

IFHOH took an active role as a founding member of the incorporated International Disability Alliance which promotes the human rights of persons with disabilities using instruments such as the CRPD. Ruth Warick was elected as Treasurer of the newly incorporated IDA at the first meeting of the legal entity on July 13-15, 2013. IDA consists of international and regional organizations united to promote the implementation of the CRPD.

As part of its UN work, IFHOH was represented at meetings of the Conference of States Parties in New York in July 2013 and, in September 2013, in conjunction with the UN General Assembly meeting of heads of states about Post-2015 Developments. This was the first time in UN history that the rights of persons with disabilities were discussed within the framework of the UN political agenda. It was an important event for our community to be recognized as part of the international disability community.

#### HEARING ISSUES

Close working relations were established with WHO's Technical Officer for the Prevention of Deafness, Dr. Shelly Chadha. We provided feedback for a new WHO document, Community-based Rehabilitation: Promoting ear and hearing care through CBR.

We were represented IFHOH at an Ad hoc Consultation on Hearing Devices Technology Transfer in LMICs was held in Geneva (LMIC refers to low and middle income countries) organized by WHO in March 2013 and provided further input to the project as it unfolded. The next steps are to develop suitable preferred product profiles and share the profiles with manufacturers through a call for interest, and to promote the need for greater access to hearing aids.

In July, 2013 Ruth Warick was a panel presenter during a side event of the Conference of States Parties in New York on ACT Technologies which has prepared a report is entitled The ICT Opportunity for a Disability-Inclusive Development Framework. As well, in September, 2013, she took part in a Task Force meeting of the World Health Organization and UNICEF which are finalizing a paper on Assistive Technology; their definition includes hearing aids as an assistive device. In the meeting she stressed the need for hearing aids to include t-coils so that hard of hearing persons can benefit from other assistive listening devices such as hearing loops, FM and Infrared systems.

Preliminary work commenced on establishing a hearing awareness day with information gathered on how other organizations have succeeded in achieving such an official day through the UN system. Further consideration is required on the date that would be favored by IFHOH member organizations.

#### OTHER PRESENTATIONS AND ACTIVITIES

An Education policy paper was developed and posted on the IFHOH website as well as in the Journal for member feedback. The paper covers the areas of barrier-free environments, captioning/subtitling in the classroom as well as for materials, language development, hearing aids and assistive technology, support services and teacher training.

We also provided input into an Education Policy Paper developed by CBM (Christian Blind Union).

Ruth Warick was one of two representatives for the Working Group on Monitoring and Evaluating Community Based Rehabilitation held in India in November 2012 and was moderated a plenary session for the first international CBR Conference.

Niklas Wenman, Hanh Duong Phuong, Marcel Bobeldijk, Avi Blau and Ruth Warick attended the third Hearing Loop conference, held in Eastbourne, England in October 2013. Ruth participated in the opening panel for the conference and EFHOH's Jan Lamby participated in the closing session for the two-day event.

Marcel Bobeldijk, President of EFHOH, represented IFHOH and EFHOH at a First Arab Regional Conference of Arab Deaf Persons in Tunis, Tunisia. Held in September, 2013, the conference was organized with the support of AECID (Spanish Agency for International Cooperation for Development). Representatives came from ten Arab countries: Algeria, Egypt, Iraq, Jordan, Lebanon, Libya, Oman, Yemen, Saudi Arabia, and of course, Tunisia. Many of the persons were also hard of hearing and interested in accessibility issues for hard of hearing persons.

In her IDA role Ruth Warick represented IDA and IFHOH at meetings in 2013 sponsored by WHO and the World Bank to develop a model disability survey for comparable collection of data about the numbers and experiences of persons with disabilities. The impetus for developing a Model of Disability Survey relates to Article 31 of the CRPD which calls upon ratifying States Parties to collect appropriate information, including statistical and research data, and Article 33 which calls for monitoring the implementation of the CRPD.

She also represents the disability community on the International Labour Organization Business Council, a role assumed in December 2013. The Council is facilitated by the ILO and consists of businesses that are keen to promote the employment of persons with disabilities. It is an opportunity to represent the disability community and also our own hard of hearing community.

#### World Federation of the Deaf

A Memorandum of Agreement was signed with the World Federation of the Deaf on October 18<sup>th</sup>, 2013 at the WFD General Assembly in Sydney, Australia. This agreement marks a new milestone in the cooperation of the two organizations. The Agreement which covers Terminology, Areas of Co-operation (e.g. captioning), Consultation and Exchange of Information, and Representation. We have already been collaborating with WFD about captioning at UN meetings.

#### International Federation of Hard of Hearing Youth

An Agreement was signed with IFHOHYP at the 2012 Congress and exchanges of information continued with participation in board meetings of each organization once a year.

#### Hearing Loss Association of America

A Memorandum of Agreement was signed with HLAA to host the 2016 IFHOH Congress in conjunction with HLAA's annual conference. The event will be held in Washington D.C. from June 23 to 26, 2016. Ruth Warick was invited to make a plenary session announcement at the 2013 Conference of HLAA in Portland, Oregon.

#### Conference and BGM 2014 in Jerusalem

We extend our thanks to our member organization in Israel, Bekol, and to IFHOH Vice-President Avi Blau for organizing the 2014 BGM for IFHOH, the AGM for EFHOH and the conference on Overcoming Hearing Barriers. A tremendous amount of work has gone into the event and we are grateful.

## Calling for Investment in Hearing Care

PRESS RELEASE - WHO Calls on Governments to Invest in Hearing Care

GENEVA, 03 MARCH 2014 (UN NEWS CENTRE) ---

The United Nations health agency is calling on Governments to invest in hearing care, as a new survey finds that many countries lack the capacity to prevent and care for hearing loss, which affects 360 million people worldwide.

According to the World Health Organization (WHO), the highest prevalence of disabling hearing loss is found in the Asia Pacific, South Asia and sub-Saharan Africa. About half of all cases of hearing loss worldwide are easily prevented or treated.

However, a report published by the agency on the occasion of International Ear Care Day, observed on March 3, 2014, says that just 32 of the 76 countries who responded to a WHO survey have developed plans and programmes to prevent and control ear diseases and hearing loss.

Many countries lack trained health personnel, educational facilities, data and national plans to address the needs of those living with ear and hearing problems. The gap between need and services is greatest in sub-Saharan Africa.

"The results of this survey are a clear call to action for governments and partners to invest in hearing care, especially at community and primary level," said Etienne Krug, Director of the WHO Department of Violence and Injury Prevention and Disability.

"The programmes must aim to benefit all, including disadvantaged parts of the population who are least able to access hearing services," added Dr. Krug.

WHO notes that a leading cause for hearing loss in younger ages, particularly in low- and middle-income countries, is untreated ear infections, which often presents with discharge from the ear. Vaccine-preventable infectious diseases such as rubella, meningitis, measles, or mumps can also lead to hearing loss.

Good ear care practices, such as reducing exposure to noise and avoiding insertion of objects into the ears, can prevent many from developing ear and hearing problems. A large percentage of people living with hearing loss can benefit from early identification and appropriate treatment.

"Ear and hearing problems and the use of hearing aids are often associated with myths and misconceptions," said Shelly Chadha of the WHO unit for the Prevention of Blindness and Deafness.

"National programmes should therefore not only focus on prevention and service provision but also on awareness-raising," Dr. Chadha noted.

### World Health Organization - Disabilities and Rehabilitation

2013 has been another important year for disability and rehabilitation, with progress on both the technical front and the policy front.

In May, the 66th World Health Assembly (WHA) adopted a landmark resolution on disability, which sets priorities for our Member States and the WHO Secretariat. One immediate consequence of the WHA resolution was the development of a WHO action plan 2014 - 2021: better health for persons with disabilities. The plan has been reviewed in all regions and will be discussed at the upcoming meeting of the WHO Executive Board in January. To date 277 different governments, organizations and individuals have contributed to this Action Plan, which will shape WHO's work in the coming years.

During the WHA the Secretariat organized a technical briefing to seek input from WHA delegates on the disability and health aspects of the High-level Meeting on Disability and Development and its related draft outcome document. The High-level Meeting on Disability and Development held on September 23 at the United Nations in New York was a key moment in the progress towards the post-MDG framework. Member States, NGOs and DPOs came together to press for inclusion of persons with disabilities in global development strategies. The outcome document from the meeting calls for an increased emphasis on core areas of WHO's work: health, rehabilitation, habilitation, assistive technologies and data collection.

Our technical work continued with the launch of the intermediate module of the Wheelchair service training package; the launch of the Guidance note on disability and emergency risk management for health, ready in time to be implemented in The Philippines after Typhoon Haiyan; and the cognitive testing of the Model Disability Survey, from which the initial results are very exciting. The first Polynesia Region Community-based Rehabilitation (CBR) Workshop took place in Samoa in June.

As is evident, the impetus created by the *World report on disability* in 2011 has continued. With the efforts of our indefatigable staff, and the inspiration and hard work of our partners across the globe, we can together remove barriers and promote health and well-being for the billion people with disabilities. We look forward to working with you in 2014.




